## **Bylaws of the Board**

## **New Board Member Orientation**

Because the Board, as the policy making authority of the Lisbon Public Schools, is responsible to the public for the success of all educational services offered by the school system, and because that success is directly dependent upon each Board member's ability to participate meaningfully in the decision-making process that governs this system, it shall be the policy of the Board to provide, as soon as practicable, for the orientation of new members. The purpose of the orientation is to help new members become quickly acquainted with their Board duties and responsibilities.

After the general election in November, the new members will receive a welcome letter (Attachment A) in their November meeting packet. New Board members may request to meet with the Board Chairperson and/or the Superintendent and other administrative personnel to give them the opportunity to request any other information they may deem desirable. Each new member will be given the opportunity to attend sessions of the Connecticut Association of Boards of Education or similar new Board member orientation at the Board's expense. New Board members should also review and become familiar with the school calendar, current budget (condensed), and the student handbook.
