6. **Report from Lisbon Central School Student Ambassadors** –

B. Nowakowski reported that the 8th grade students are learning the following: In Language Arts, he reported they are doing another book report and they have just finished their thesis papers and essay tests. He stated that they were difficult but they all made it with great scores. In Math, they have just finished the Pythagorean Theorem lesson and are learning how to find distances of an angled line on a graph. They have completed the Eighth Grade curriculum and are now studying for the SBAC test. In Science, they are learning about the evolution of creatures, how they begin from single cells and become large, functioning creatures. He finds it very fascinating how the organism can evolve in such a way over millions of years. In Social Studies, they are learning about the industrial revolution in North America and the hardships of the slaves in the South. They are learning about the arguments of slavery, how the workers in the textile mills in the North were in difficult working quarters. In Spanish, they are learning about the foods of Central and South America. They have viewed recipes and learned unique foods.

D. Jeffs reported that the 7th grade students are learning the following: In Language Arts, she reported they have been discussing their first research paper and have been going over the first of very many steps of how to do a research paper. Tomorrow the class will be choosing authors and learning how to set up the eighth grade book report. In Math, they are currently going over the geometry of composite figures and once that unit has finished, they will be moving onto scale factors and reviewing for the upcoming SBAC test. In Science, they finished their worm dissection activity last week, reviewed their lesson on food webs and ecosystems and are now starting to learn and discuss population studies. In Social Studies, they have been reading about Brazil and its environmental issues. They will also be watching an educational documentary about the Amazon Rainforest, leading up to a research paper. In Spanish, they are starting a new unit and learning how to tell the time and how to describe their daily class schedule.

A. Cuff reported that the 6th grade students are learning the following: In Language Arts, she reported they are learning about a woman named Yoshiko and her and her family's hardships during the Pearl Harbor bombing. In Math, they are practicing for their upcoming SBAC test. This test includes what they have learned such as percentages, ratios, rates and lots more. In Science, they are learning how different organisms reproduce in different ways. She finds it very interesting to learn how others reproduce differently. In Social Studies, they continue to learn about Ancient Rome. She enjoys learning about the different mechanisms that they had back then.

8. Administrators' / Superintendent's Report

- a) Lisbon Central School – Mr. Brian Apperson provide an update on the March Student of the Month. Testing is underway for grades 3,4,5 and 7. Grade 6 will begin their ELA test this week. He gave an update of the computer purchase order. He has been tracking the shipment and hopes to receive them shortly. Lastly, the LCS Variety Show videos are being finalized. Mr. Gracia has offered his assistance with the videos. The final product will be put into a video. Many thanks to Mrs. Gilgenbach and the PBIS staff!
- b) Special Education –Mr. Scott Trepanier reported on the Special Education Enrollment Numbers, and PreK Screening will take place on May 7th.
- c) Business Office – Mrs. Diana Cormier provided an update regarding Medicaid.
- d) Building and Grounds –Mr. Brian McGlew will provide an update regarding the LCS physical plant. He reported the security cameras have been cleaned, and the fire protection system has been tested. She has applied for the REAP Grant for approximately \$33,000. The status should be known in the summer. Next, the Security Grant is on the horizon and Mrs. Keating and Mr. McGlew will be working on that one. Mrs. Keating would like to hold a Reopening of School meeting next week and will reach out to the committee members. Lastly, Mrs. Keating reached out to Ledyard Superintendent Jay Hartling. This is in relation to the possibility of having Ledyard High School as an option for our students. Last week was Spring Break, so she will reach out again.

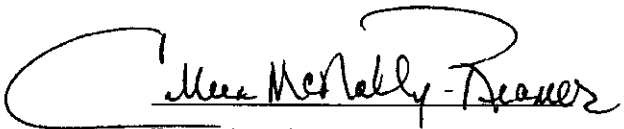
